The John J. Wright Alumni Association had its beginning in the mid 1950's under the leadership of Mrs. Thelma Pryor as president. Among the purposes of the organization was to retain a connection among John J. Wright Alumni and the school community. The organization's activities included annual days held in April. Classes at ten year anniversaries were recognized through their involvement in the program of the day.

Over the years, for various reasons, the organization became dormant. In 1993, the John J. Wright Alumni Association was reorganized and chartered as the John J Wright Alumni Association, Incorporated. Its purposes: to preserve and disseminate the history of African Americans in Spotsylvania County, Virginia; to promote, enhance and foster education and community welfare in the county in a charitable manner; and to promote fellowship among the alumni of Spotsylvania (Snell) Training School, John J.

Wright School and John J. Wright Consolidated School.

The Alumni Association of 2007 is committed to these principles, we are charged to preserve and share the legacy that is our heritage. We honor and thank those upon whose shoulders we stand.

We encourage our young people (our legacies) by supporting their effort to continue their post high school education through our scholarships and stipends. As participating and contributing citizens, they represent our bright hope for the future.

THE MAN BEHIND THE NAME

Who is John J. Wright? I wondered as I entered the halls of John J. Wright Intermediate School as a 10 year old sixth grader. I recall visiting the school library where there was an area dedicated to educating all who entered about his life and accomplishments. It would be fifteen or so years before I would truly know and understand the contribution of this man's life and legacy.

John J. Wright was born in 1863 on Blanton's Farm in Massaponax. At the time of his birth, it was unlawful for blacks to read or have any resemblance of an education. However, Mr. Wright persevered and obtained a formal education and eventually graduated from the Virginia Normal and Industrial Institute which is now known as Virginia State University.

After obtaining his college degree in 1894, Mr. Wright returned to Spotsylvania County where he began his career as an educator, empowering many, encouraging self-discipline and instilling the value of self-reliance. He also assumed the role as one of the most prominent African-American businessmen in the area owning over 200 acres in Spotsylvania and 130 acres in Caroline county.

Mr. Wright's perseverance, dedication and most importantly his love of community made education possible for many African-Americans. His contributions to this community were endless and established a foundation by which many African-Americans in Spotsylvania County, even until today, are still benefiting.

OUR NEW HOME

The Spotsylvania School Board decided in 2003 to construct a replacement building for John J. Wright Middle School because of the cost of necessary improvements to the 60 year-old school and the inability to purchase additional land for

expansion. The John J. Wright Middle School Utilization Committee formed in 2004 to study options for utilizing the facility when it became available following the opening of Post Oak Middle School in 2006.

Chaired by Courtland High School Assistant Principal Mary Speight, a former John J. Wright teacher and long-time Spotsylvania resident, the committee included instructional staff, the Director of Maintenance, and county representatives.

The School Board, as recommended by the Utilization Committee, approved the relocation of seven programs to a central facility, which will save the county approximately \$7 million in classroom space. This action will allow for future program expansion as well as serving the needs of the community.

The School Board contracted with an architectural firm, BCWH of Richmond, for assistance in designing the renovation to accommodate the proposed uses.

- Alternative High School Graduation Alternatives and Non-Traditional Education in Spotsylvania County (GATES)
- General Education Development (GED)
- Preschool
- Early Childhood Special Education
- Professional Development
